In order to participate in/with Wing Chun Science, LLC (WCS), I, the participant/student, freely and voluntarily acknowledge and agree to the following:

- I may encounter strenuous, physical activities (with or without combative props or exercise equipment) that may incur bodily injury, bruising, aches and pains during or after the classes and **DO NOT/WILL NOT** hold Wing Chun Science, LLC (WCS) accountable and hold them harmless.
- I understand it is solely my responsibility and discretion in agreeing that I am physically able to perform any/all activities. I willfully and willingly acknowledge the intensity of each class and join with full cognizance and consent.
- Wing Chun Science, LLC (WCS) and all its representatives are NOT responsible for prior or current medical conditions that would impede, stifle, slow down, hinder, hurt, exasperate or flare during any classes at the Wing Chun Science, LLC facility.
- Parents/legal guardians should stay in the facility and only observe the child's training. If leaving a minor at Wing Chun Science, LLC (WCS) during class, I, the parent/legal guardian of the minor/participant, **DO NOT/WILL NOT** hold any person(s) of Wing Chun Science, LLC (WCS) accountable and hold them harmless to any/all situations.

- Cancel anytime with advanced written/verbal notice. Any prior charges/auto deductions/ payments/purchases are non-refundable.
- **Credit cards must be on file for automatic monthly deductions on our private classes, monthly/promotional packages. Fighter/students/members' information will not be shared with any third party.**
- Classes may be canceled at any time due to weather, property management closures, Holidays, fight events, personal and emergency reasons with/without notice. ***FOLLOW @wing.chun.science TO RECEIVE LATEST UPDATES.***
- Please bring a face/hand towel. Food/Sticky Beverages/glass containers are not allowed anywhere in the facility. **ONLY Water in plastic bottles/thermoses are allowed.**
- To be considerate, respectful and to prevent illnesses to our fellow members/co-students, we ask all participants to help clean/wipe down/disinfect the equipment, gear and mats after use.
- **Cage use is only for fighters with the supervision of a coach and/or with cage/ring experience. WCS may close the facility (up to 3 days) when WCS fighters have a match.**
- **Results may vary.** WCS does not make promises of outcomes in training/workouts/ placement in amateur and professional fights. **Further discussion with the WCS head coach and waiver/policy, contract and pricing must be signed separately for fighters in training/fighter's camp.**
- **Bathroom use is only at the food court.**
- I, the participant/student, acknowledges that it is my responsibility to read all parking signs and **do not/will not** hold Wing Chun Science, LLC (WCS), and the Building Leasing Management and all its representatives responsible if any parking tickets or towing fees are incurred, any type of car accidents/car incidents, theft or fire to the participant's or minor parent's vehicle.
